Time of fact: 15.57

Session: Race 2

Facts: The Competitor failed to properly operate the on-board camera system.

Offence: Breach of article 23.7 of the FRECA Sporting Regulations

Decision: Financial fine of 300 Euros

Reason: According to Art. 23.7

only one video camera kit is allowed. *Art. 23.7*
According to the on-board images produced by the camera of the car 74 retrieved after race 2 of the Spa Event, and later having been confirmed by the various customer race engineers, reporting to the race director, the camera model of car 74 does not match the camera model mandated by the above referenced technical bulletin.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.




Item 26D - Video System of Technical Bulletin TB_2025_FRECA_02_EN dated 10-03-2025 reads: "only one video camera kit is allowed: AIM Smarty Cam 3.1".


